1. CALL TO ORDER

Chair Joseph called the meeting to order at 10:33 AM.

4. APPROVAL OF THE MAY 21, 2024 MEETING MINUTES*

John Lanum and Kelly Travelbee mentioned that calendar invites for three upcoming meetings have been sent out, which cover 2025 Safety Target setting (July 8th) and 2022-2025 TPM Mid-Performance Period Reporting (July 15th, August 22nd).

Michele Zawerucha mentioned that a new Rural Obligation Specialist has been hired.

Chair Joseph stated that the next MTPA meeting will be held during the 2024 MTPA Conference in Muskegon on August 2nd. Ali Townsend mentioned that the Awards Committee will meet immediately after this meeting.
